through PVC pipes. Each block contains five percolation pits of size 1'0"x1'0"x10'0"

The water is taken to percolation pits by 2" PVC pipes.

Percolation Pit

Percolation pit consists of size 1'0"x1'0"x10'0" which is filled by broken brick jelly and top
layer is filled by river sand.

The water percolates through the percolation pits gets filtered by river sand and brick jelly and
the water enter into earth and increase the water level.
